BACKGROUND The City received a Notice of Revocation from the State of MN ordering the City to revoke the liquor license for Pour L'Amour Inc. City staff provided notice to the owner on September 16, 2022 regarding the potential revocation of their license. After not receiving a response, the City provided a second notice to the owner which provided the owner 8 days to request a hearing regarding the consideration of revoking the license. Delivery of the second notice was confirmed by staff and the City has not received a request for a hearing by the license holder. Attached is a resolution revoking the City license per the order by the state. RECOMMENDATION: Motion to approve the Resolution Revoking the Liquor License for Pour L'Amour as presented.		

Councilmember ____ introduced the following resolution and moved for its adoption:

**CITY OF ANNANDALE
RESOLUTION 22-____
REVOKING LIQUOR LICENSE**

WHEREAS, the Annandale City Council approved the annual On Sale Intoxicating Liquor License including Sunday Sales for Pour L'Amour, Inc (DBA Pour L'Amour) located at 220 Poplar Lane, Annandale on July 11, 2022 effective August 1, 2022, and

WHEREAS, the City received a Notice of License Revocation dated September 9, 2022 from the MN Department of Revenue stating the City must notify the Pour L'Amour Inc that their license may be revoked, and

WHEREAS, the Notice of License Revocation additionally stated the City must revoke the license held by Pour L'Amour Inc if a clearance certificate is not received from the Department of Revenue within 30 days, and

WHEREAS, The City provided Notice of Revocation to the owner of Pour L'Amour Inc via certified mail on September 16, 2022, and

WHEREAS, The City did not receive a clearance certificate from the Department of Revenue within 30 days of the Notice of Revocation, and

WHEREAS, The City provided additional notice via hand delivery to the owner of Pour L'Amour Inc dated October 17, 2022 informing the license holder they had eight days to request a hearing before the City Council regarding the reason why their license should not be revoked, and

WHEREAS, The City has not received a request for a hearing from the license holder.

NOW, THEREFORE, BE IT RESOLVED, the Annandale City Council revokes the On Sale including Sunday liquor license for Pour L'Amour, Inc, 220 Poplar Lane South, Annandale effective October 28, 2022.
